Remove contaminated clothing. Assure adequate flushing of eyes by separating eyelids with fingers. INHALATION: remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. INGESTION:

DO NOT induce vomiting. Give 1-2 cupfuls of water. GENERAL: Wash contaminated clothing.

Section VII Precautions for Safe Handling and Use

Steps to be Taken in Case Material is Released or Spilled Evacuate unprotected personnel from area. Wear dust mask if necessary, protective gloves and chemical safety goggles. Do not breath vapors. Sweep up, place in a plastic bag and hold for waste disposal. Ventilate area and wash spill site after material pickup is complete.

Waste Disposal Method Dispose of material in accordance with all applicable Federal, state, and local regulations.

Precautions to be Taken in Handling and Storing Store in a cool, dry, well-ventilated area in tightly-closed, plainly-labelled containers. Store in a resistant container. Protect against moisture, physical damage and light. Maintain adequate ventilation. Wash thoroughly after handling. Do not ingest or breathe dust. Protect exposed tissues.

Other Precautions Containers, even when empty, will retain residue and vapors. Always obey hazard warnings and handle empty containers as if they were full. Do not breathe dust.
