SECTION 3 Hazards Identification

EMERGENCY OVERVIEW: May be irritating to skin and eyes and respiratory tract.
PRIMARY ROUTES OF EXPOSURE: Ingestion, inhalation
EYE CONTACT: May be a mild to severe irritant to the eyes.

INGESTION: Seek medical assistance immediately. Keep the victim calm. Give the victim water (only if conscious). Induce vomiting only if directed by medical personnel.
